## Please read this information before you complete the form

You have options in how you provide your Tax File Number (TFN) to us. You can do so immediately via MemberOnline or call us on 1800 675 839. Alternatively, you can complete this form.

You are not required to provide your TFN to us. If you choose not to provide your TFN you may pay more tax on your super benefits than necessary, and Prime Super will be unable to accept personal (non-concessional) contributions from you. For more information about your TFN contact the Australian Taxation Office (ATO) Superannuation Hotline on 13 10 20.

Under the Superannuation Industry (Supervision) Act 1993, Prime Super is authorised to collect your TFN and will only use it for lawful purposes including to identify or find your lost super, merge accounts in Prime Super, calculate tax on payments and provide information to the ATO. We may disclose your TFN to another super fund when your benefits are being transferred, unless you request otherwise in writing.
