

## Important administration fee and cost changes for members joining Prime Super on or after 8 May 2025 8 May 2025

Please read this document that accompanies our 31 March 2025 PDS, as it contains important information about the administration fee and cost changes contained in the PDS, occurring from 1 July 2025. We will be updating the PDS again on 1 July 2025 to reflect these changes. Administration fees and costs that are disclosed in the 31 March 2025 PDS will continue to apply up until 30 June 2025.

## What is changing?

## Changes to fees and costs as of 1 July 2025

As of 1 July 2025:

The administration fees and costs for Accumulation accounts (Super Fund) will change as follows:

Current administration fees and costs only	1 July 2025 administration fees and costs only
<b>\$1.53</b> subject to a 15% tax rebate (\$1.30 net) per week	<b>\$1.50</b> per week (no tax rebate)
Plus	Plus
<b>0.588%</b> subject to a 15% tax rebate (0.500% net) p.a. of your account balance, capped at <b>\$588</b> (\$500 net after the tax rebate) p.a.	<b>0.33%</b> p.a. of your account balance (no tax rebate), capped at <b>\$825</b> p.a.

The administration fees and costs for Pension accounts (Transition To Retirement and Retirement) will change as follows:

Current administration fees and costs only	1 July 2025 administration fees and costs only
<b>\$1.30</b> per week	<b>\$1.30</b> per week
Plus	Plus
<b>0.500%</b> p.a. of your account balance, capped at <b>\$500</b> p.a.	0.33% p.a. of your account balance, capped at \$825 p.a.

The effect of these changes is that Prime Super will:

For all accounts:

- reduce the asset-based administration fee,
- increase the asset-based fee cap.

For Accumulation accounts:

- reduce the fixed administration fee,
- no longer rebate the 15% tax to members.

Prime Super will update its PDS as of 1 July 2025 to reflect these changes.
